Applicant's signature attests financial responsibility, ability, and agreement to pay our invoices in accordance with the following terms: (1) Net 30 days. This agreement shall be construed under the laws of the State of Ohio, and if legal action is brought to enforce this agreement, that Stark County, Ohio, shall be the exclusive jurisdiction and legal venue for said action. (5) Applicant agrees to pay DCI a \$25.00 service charge on each dishonored check returned.
